Community Garden Update:

M. Vandenbrand updated C&C on the following:

- In 2 weeks, vegetables should be available to distribute to the Community
- A berry picking was organized for Community & Band Members. 13 people attended.
- The garden workers have been working with Maria to make jam at the Mounds. The jam will be packaged and distributed in the Community.
- 7 gens is subsidising the wages of all who are working at the Community Garden.
- Maria is designing some side research projects to keep the workers engaged.
- It was expressed that this is a pilot project that can hopefully be developed over time to institute programs like a year-round greenhouse & an agricultural beef program to make steps toward food sovereignty for the Nation.

Tribal Health:

L. Hyatt, Chief R. McGinnis, and J. Hunter-Connon will be having a follow up call with Tribal Health regarding a breach of information to an outside source by one of their staff members.

FMB/Tiny Home Project:

It was discussed that the there is a housing crisis on the Community. Funding for a Tiny Home Project or FMB will be explored. When the Land Code is passed, it will also free up some funds and lands to expand the Community.

L. Hyatt: speak with Lands and Housing (when hired) about researching a tiny home project.

New Band Office:

R. Froese has identified deficiencies in the construction of the New Band Office. A meeting will be held with him this week to discuss these and the next steps to start rectifying them.

Stories of the Land:

R. McMahon has submitted a proposal to film a Youtube series that he received funding for at the Mounds. This would entail Members and possibly staff being interviewed. C&C agreed to the use of the location but requested that they be kept on the loop of the production to ensure the messaging is representative of RRFNs, its history and the Mounds. A presentation by R. McMahon on the project was requested.

L. Hyatt: organize a presentation by R. McMahon to C&C and meet him in site when he arrives to express C&C's direction.

New Gold Discrimination Follow-Up

Chief R. McGinnis has a call set up with New Gold CEO Renaud Adams, at which he will discuss the following:

- Why was a senior staff member who made derogatory comments about RRFNS and its Chief not terminated? What, in fact, was the outcome of this complaint?
- Chief McGinnis will be requesting an analysis of the lines of progression for First Nations People vs. Caucasian People as there is a clear discrepancy when it comes to promotions and raises.

School Bus Driver:

Funding for a new School Bus driver has been received and the position will be advertised.

Education Awards:

M. Horton is planning on moving forward with a socially distanced version of the Education awards. The plan thus far is that awards will be delivered to individual houses with the Chief and drummers.

Onikaajigan Dissolution and Board Representation:

RRFNs have completed their part of the Oni Dissolution. A full audit of the company was requested. This request for Audit was denied. A motion was made to appoint S. McGinnis to the Oni Board.
