The On Call Child Care Program worker is responsible for receiving and responding to all crisis calls after hours. The On-Call CCP Worker plays a vital role in ensuring the safety and well-being of children and families during after-hours emergencies. This position requires quick thinking, effective communication skills, and a strong commitment to child protection principles. The On-Call CCP Worker responds to referrals and assesses the urgency of situations, determining appropriate interventions to safeguard children until regular services can resume. They work collaboratively with community resources, law enforcement, and other stakeholders to address immediate safety concerns.

PRIMARY ACCOUNTABILITIES

- Receive and respond to referrals during after-hours periods.
- Assess the urgency of each situation, prioritizing cases based on the level of risk to children.
- Gather detailed information from referral sources, including allegations of abuse or neglect.
- Contact relevant parties, such as community on-call workers or supervisors, to coordinate response efforts.
- Conduct interviews with children, caregivers, and other relevant parties to gather additional details as needed.
- Collect information on family dynamics, support networks, and potential safety threats.
- Document all safety interventions and follow-up actions taken during emergency responses.
- Maintain accurate and detailed records of all interactions, assessments, and interventions.
- Communicate effectively with law enforcement, medical professionals, and other stakeholders involved in emergencies.
- Ensure seamless transitions between after-hours services and regular service providers for ongoing support.

POSITION REQUIREMENTS

- Experience in social work, psychology, or a related field.
- Child welfare professional series 9 modules.
- Weechie-it-te-win on-call training considered an asset.
- Knowledge of community health issues and programs related to Rainy River First Nations.
- Previous experience in child protection, crisis intervention, or related social services.
- Knowledge of child welfare legislation, policies, and procedures.
- Strong communication, assessment, and decision-making skills.
- Ability to work effectively in high-pressure, fast-paced environments.
- Excellent oral and written communication skills.
- Demonstrated competency with computers and various software programs.
- Knowledge and respect for Rainy River First Nations' culture, traditions, practices, and lifestyles.
- Criminal Record Check and vulnerable sector screening.
- Valid driver's license and satisfactory driver's abstract.
- Adherence to Rainy River First Nations' Drug Testing Policy.
